Key 2025 Tax Deadlines for C Corporations

January 2025

- **January 15:**
 - Payment of the Q4 installment of 2024 estimated taxes using Form 1120-W.
 - Payments via EFTPS must be scheduled by 8:00 p.m. EST on January 14.

March 2025

- **March 15:**
 - File your 2024 corporate income tax return (Form 1120) or request an automatic six-month extension using Form 7004. Any remaining 2024 taxes must be paid to avoid penalties.

April 2025

- **April 15:**
 - Pay the first installment of 2025 estimated taxes using Form 1120-W.

June 2025

- **June 17** (adjusted for the weekend):
 - Pay the second installment of 2025 estimated taxes using Form 1120-W.

September 2025

- **September 15:**
 - Pay the third installment of 2025 estimated taxes using Form 1120-W. For those who filed an extension in March, this is also the final deadline to submit your extended 2024 corporate tax return (Form 1120).

- **December 15:**
 - Pay the fourth and final installment of 2025 estimated taxes using Form 1120-W.
